It is on this 29<sup>th</sup> day of October, 2010, hereby

ORDERED AS FOLLOWS:

1. Plaintiffs' Subpoena Duces Tecum served on Google, Inc. ("Google") dated June 25, 2010 ("Subpoena") and any other subpoena issued by Plaintiffs seeking the identity or information leading to the identity of the person who made anonymous posts to the Blog, including without limitation, Defendants Doe, is hereby quashed and of no force and effect;
2. Any order authorizing the issuance or any subpoena or discovery seeking the identity or information leading to the identity of the persons who made anonymous posts to the Blog, including without limitation, Defendants Doe is hereby vacated;
3. Plaintiffs and their counsel shall immediately withdraw any and all outstanding subpoenas or discovery requests issued regarding Defendants Doe, including without limitation, the Subpoena served on Google, Inc.,
4. Within one day, Plaintiffs' shall provide to Defendants Doe's counsel a list of names and addresses of any and all persons or entities who have been served with any subpoenas or discovery requests seeking the identity or information leading to

the identity of the person who made anonymous posts to the Blog, including  
without limitation, Movants Doe \*

IT IS FURTHER ORDERED that counsel for Defendants shall serve a copy of this order  
on counsel for Plaintiffs within 7 days of the date herein.
